No entry shall be accepted from: A dog or handler disqualified from the ASCA Conformation program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA. AWARDS: High in Trial Aussie, High Combined and High Scoring Junior. High Scoring Australian Shepherd will be awarded if HIT is not an Australian Shepherd. Qualifying ribbons will be handed out to each qualifier in Rally with scores of 170–194. X Qualifying ribbons will be handed out to each qualifying score 195 and higher.

DIRECTIONS

FROM THE SOUTH: Take I-95 to Exit 100, take Route 272 West. Route 273 south to right on Middle Road. Facility is .8 of a mile on your left. You will see the "Welcome to the Brandywine Valley ASC dog show" sign. The show site is in the freestanding building on approximately 5 acres of open fields with grass.

FROM THE NORTH: Take I-95 South to Exit 3, Route 273 north towards Newark, DE approximately 13 ½ miles to a left on Middle Road. Route 273 will take you right through the heart of the University of Delaware Campus "Main Street" and then back out into the country. Middle Road will be your next left after passing Wesley's Restaurant on your left.

FROM THE WEST: Take Route 30 North to Route 896 South to Route 796 South take a Right onto Appleton Road, Right on Route 273 North, left on Middle Road immediately past Wesley's restaurant.
